**Recommended to Limit COVID-19 Transmission**

While the Los Angeles County Department of Public Health (Public Health) reports small increases in COVID-19 infections over the past four weeks including increased transmission among students and staff, Public Health is working with schools to distribute COVID-19 tests and updated information about COVID-19 safety precautions. Public Health encourages staff and students, especially those with recent exposures, travel or any symptoms, to take an at-home antigen test right before returning they return to school.

Families can help reduce transmission risk by making sure they talk to their children about common safety precautions, like washing hands frequently, covering coughs, and following isolation and close contact guidance if children are infected or exposed. Parents should make sure their children are up to date on their vaccines and talk with their child's health care provider about getting vaccinated for both COVID-19 and flu this fall.

If a student tests positive for COVID-19 and was at school two days prior to a positive test on the start of COVID symptoms, parents should immediately return school officials. Students and staff who test positive for COVID-19 must stay home and avoid regardless of symptoms and vaccination status. While those infected with COVID are required to isolate for a minimum of five days, it is not necessary to stay home away from others after an exposure to COVID unless you have symptoms and/or a positive after an exposure. Individuals who have been exposed should test as soon as possible after an exposure and again three to five days after exposure. Masking for 10 days after an exposure when no symptoms otherwise remains a best practice. Those who develop symptoms and test negative should repeat the test after 48 hours and remain away from others while symptomatic. Children who are sick should not attend school.

Some meeting offers additional precautions in settings where transmission is possible, those who are able, non-symptomatic and with minimal health conditions may want to use a well-fitting respirator mask when visitors, especially in areas that are crowded and/or poorly ventilated. No one can be prohibited from wearing a mask in any setting, and schools and businesses are allowed to require wearing of both their employees and

In Los Angeles County, public health tests remained higher than expected. Data with lag 3-4 weeks due to the time it takes for specimens to be sequenced. For the week ending 8/10, 85.5 accounted for 7 percent of cases. COVID-19 strain XBB.2.3 accounted for 25 percent of sequenced specimens and XBB.2.3 accounted for 25 percent of sequenced specimens. COVID-19 strains currently circulating are descendants of Omicron. XBB and it is expected that current precautions will remain effective to prevent severe illness or death.

The Public Health Call Center is open seven days a week, from 8:00 a.m. to 8:00 p.m. The free service will connect callers with a person who can answer their questions, coordinate free healthcare to receive COVID-19 treatment and help make a vaccination appointment, including for people who are homebound. The number is 3-885-562-8673.

Los Angeles County is the Low Hospital Admission Level with 8.4 weekly COVID-19 hospital admissions per 100,000 residents, up from 7.1 for the seven-day period ending 8/10. The CDC has updated COVID-19 Community Levels with Hospital Admission Levels, which can help individuals and communities decide what prevention actions they can take based on the most recent information.
