1 **DECLARATION OF KENT R. RAYGOR**

2 I, Kent R. Raygor, declare as follows:

3 1. I am a partner with Sheppard Mullin Richter & Hampton LLP, attorneys of record for
4 defendants County of Los Angeles Department of Public Health, Muntu Davis, M.D., and Barbara
5 Ferrer Ph.D., MPH, M.Ed (collectively “**LACDPH**”) in this action. If called as a witness, I could
6 and would competently testify to all facts stated herein.

7 2. Attached hereto as **EXHIBIT A** is a true and correct copy of the *ex parte* notice e-
8 mail I sent on September 18, 2023 to Julie Hamill, counsel for Alliance. Ms. Hamill responded in
9 writing on September 18, stating: “Yes, I will appear and oppose.”

10 3. After the hearing before the Court on September 14, 2023, counsel for Twitter/X
11 (Jonathan Hawk), Ms. Hamill, and I met in the hallway outside Department 69. Mr. Hawk and Ms.
12 Hamill discussed the protective order that had been discussed with the Court during the hearing.
13 Mr. Hawk repeated that Twitter/X still needed a protective order and would agree to certain
14 redactions by Ms. Hamill. Ms. Hamill expressly agreed to a protective order and stated that she had
15 no desire to disseminate Twitter/X materials. On September 15, 2023, I sent an e-mail to Ms.
16 Hamill along with supplemental responses by LACDPH to Alliance’s discovery requests. In it, I
17 stated:

18 “Please let us know when you have a draft of the stipulated protective order you are
19 discussing with X Corp ready for our review. We will produce documents once it is
20 entered.”

21 She responded on September 15, denying she ever agreed to a protective order. I then spoke with
22 Mr. Hawk. He confirmed what I, too, had heard in the hallway, namely that Ms. Hamill had agreed
23 to a protective order.



24 4. Almost from the beginning of this case, Ms. Hamill has been unprofessional in
25 dealing with Defendants’ counsel. She has been posting documents produced in this case for
26 purposes having nothing to do with the litigation of this matter. She has done so on her personal
27 Twitter feed and Plaintiff’s website, and has been interviewed on talk shows, podcasts, and news
28 programs about activities and documents produced in this case. None of that has any legitimate






1 purpose in connection with the litigation of this matter. It is only done to raise Ms. Hamill's
2 political profile, generate business for her law practice, and generate donations from the public to
3 fund her lawsuit through her crowdfunding solicitations made on her Twitter feed and the Alliance
4 website.

5 5. Unfortunately, her extra-judicial actions have generated repeated harassment of
6 Defendants' witnesses, Defendants' counsel, and even a potential death or injury threat directed at
7 me. In response to tweets from Ms. Hamill immediately following the deposition of Dr. Ferrer, Mr.
8 Morrow, LACDPH's Chief of Communications, received the following e-mail:

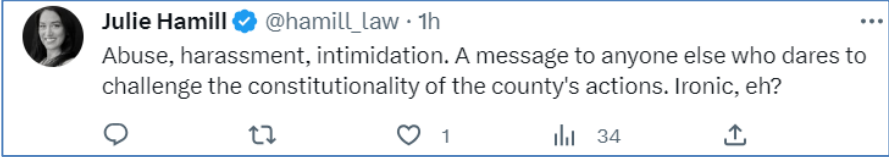

She now also adds Twitter’s counsel at White & Case to the mix:



Other examples are marked in **EXHIBIT B** hereto, which is a collection of some of Ms. Hamill’s posts about this case and replies thereto, gathered and copied by our paralegal, Lily Chu. As can be seen therein, such posts often inflame her followers. Ms. Hamill appears to have either deleted or she or Twitter/X has archived any posts older than June 19, 2023 so we are no longer able to see them.

7. Ms. Hamill’s extra-judicial commentary and posts are not professional or decorous and make it difficult to simply litigate the merits of this dispute. We are repeatedly attacked. In four communications on April 13, 14 (twice) and 17, 2023, Ms. Hamill falsely accused my law firm of spoliating evidence (*i.e.*, LACDPH’s Twitter feed) and refused to simply talk with us to try to work through her questions and those raised by our discovery meet-and-confer letter. Ms. Hamill and I spoke on April 24, 2023 to try to work out all outstanding issues. During the call, she called me “rude”, “dismal” and “condescending”. She falsely stated I have “repeatedly threatened” her, a statement she has repeated to me on other occasions. I have never threatened her. Nevertheless, I continued to try to work out our differences and move things forward. I explained to her how there was no spoliation and that she was misinformed about how Twitter archives older posts. She asked us to produce LACDPH’s Twitter archive at Dr. Ferrer’s May 3, 2023 deposition and we did, but she never apologized for falsely accusing us of spoliation. Instead, she has continually accused us of lying and, based on that false accusation, has refused to talk with us unless we speak only in writing, and, if we speak orally, will only do so if we record the conversations.

1 8. Accusing us of “abusing”, “harassing”, “intimidating”, and “threatening” her and
2 Alliance’s members has become one of Ms. Hamill’s themes. We have never done any such thing.
3 The following are just a handful of examples of such attacks (all emphasis added):

- 4 ▪ “I don’t imagine the legislature intended to create a system wherein a Big Law firm
5 with limitless resources *abuses* discovery processes to *harass* and *harm* citizens
6 trying to enforce an important right affecting the public interest.” [April 14, 2023 e-
7 mail from Ms. Hamill to me.]
- 8 ▪ “I am not going to allow you to *abuse* and *harass* the parents in this organization.”
9 [May 3, 2023 e-mail from Ms. Hamill to me.]
- 10 ▪ “Unfortunately, because of your *abusive* and *dishonest* conduct throughout this
11 litigation, I am unable to meet and confer with you off the record going forward. I
12 am happy to speak with Valerie, but I am not open to any off-record conversations
13 with you.” [May 3, 2023 e-mail from Ms. Hamill to me.]
- 14 ▪ “[Alliance] is unable to conceive of any legitimate purpose for this demand beyond
15 *harassment, annoyance, and intimidation* by [LACDPH].” [Stated once in
16 Alliance’s April 17, 2023 amended responses to LACDPH’s form interrogatories and
17 three times in its April 28, 2023 responses to LACDPH’s document demands.]
- 18 ▪ “Counsel for [LACDPH] is on notice that any further *abuse* and *harassment* of Ms.
19 Hamill or any members of the Alliance will be met with *additional requests for*
20 *sanctions.*” [Alliance’s May 19, 2023 supplemental responses to LACDPH’s special
21 interrogatories.]

22 9. Ms. Hamill repeated those attacks in her May 26, 2023 motion for sanctions and
23 contempt against me:

- 24 ▪ “ This motion for *sanctions* arises out of counsel for LADPH’s *abusive* attempts to
25 *harass* and *intimidate* Alliance members into further silence.”
- 26 ▪ “ This motion for sanctions is brought to curb *abuse* of the discovery process by
27 defense counsel Kent Raygor”

- 1 ▪ “This motion seeks an order of monetary *sanctions* and *contempt* against Mr. Raygor
2 for his *abusive* conduct.”
- 3 ▪ “Alliance seeks an order from the Court prohibiting Mr. Raygor from engaging in
4 similar *abusive* and *harassing* conduct in the future”
- 5 ▪ “I emailed Mr. Raygor to take the deposition of Brett Morrow, scheduled for May 5,
6 2023, off calendar until we get a ruling from the Court regarding the *abusive*
7 conduct.”
- 8 ▪ “Counsel for Alliance cannot conceive of any valid reason for Mr. Raygor’s conduct,
9 aside from wasting time on the record to avoid having his client testify, and to *harass*
10 and *intimidate* both Ms. Burwick and Ms. Hamill.”

11 10. It continued in Ms. Hamill’s June 19, 2023 reply brief in support of her motion for
12 sanctions and contempt:

- 13 ▪ “The 58-page meet and confer letter attached to Mr. Raygor’s declaration further
14 demonstrates the *abusive* and *harassing* nature of County’s attorney in this action,
15 including *attacking* and *threatening* counsel personally.”
- 16 ▪ “Alliance seeks an order from the Court prohibiting Mr. Raygor from engaging in
17 similar *abusive* and *harassing* conduct in the future”
- 18 ▪ “Alliance has *no reason to believe* that Mr. Raygor will begin to conduct himself in
19 an *ethical, honest, or non-abusive* manner.”

20 11. She continued that theme during the June 26, 2023 oral argument on the motion:

- 21 ▪ “MS. HAMILL: And this continued a pattern of *abuse* and *harassment* that
22 my clients have been subject to by the County before this lawsuit was filed and has
23 continued after filing the lawsuit.” [June 26, 2023 Tr., at 9:13-16.]
- 24 ▪ “MS. HAMILL: Your honor, I would just like to reiterate that members of the
25 Alliance and myself, as shown in the opposition declaration and exhibits, have been
26 subject to so much *abuse* and so much *harassment* for simply attempting to speak up
27 against public health orders.” [*Id.* at 10:3-8.]
- 28

- 1 ▪ “MS. HAMILL: And I am fearful that going forward we will continue to be
2 subject to the same *abuse* and *harassment* that we experienced, and that is on the
3 record on this day of May 3rd. That is why I filed the motion. I filed the motion to
4 curb further discovery abuses in the future.” [*Id.* at 10:21-26.]
- 5 ▪ “MS. HAMILL: . . . [M]y personal practice is that I will not have any off-record
6 discussions with Mr. Raygor based on a pattern of *dishonesty*. And so that – I will
7 continue that going forward. I can have discussions –” [*Id.* at 11:16-12:4.]

8 12. On July 13, 2023 – six days after the July 7, 2023 deposition of LACDPH’s Chief
9 Communications Officer, Brett Morrow – Ms. Hamill appeared on the John Phillips talk show on
10 KABC 790 AM. A recording of the interview can be found at: [https://www.kabc.com/the-john-](https://www.kabc.com/the-john-phillips-show/)
11 [phillips-show/](https://www.kabc.com/the-john-phillips-show/). She publicly mischaracterized happened at the Morrow deposition. For example:

- 12 ▪ [at 04:30]¹ MS. HAMILL: “And, uh, counsel for the County *attempted to kick her*
13 *[Roxanne Hoge] out*, but we held the deposition on my turf this time, and he wasn’t
14 allowed to physically remove her and so he stopped trying to fight me on it.”

15 I did not attempt to kick Ms. Hoge out of the deposition. In fact, I expressly stated on the
16 transcript, “I’m not going to kick her out”. [July 7, 2023 Morrow Deposition Transcript, at
17 13:2-14:5.]

18 13. In another example from that interview, she mischaracterized the testimony about
19 threats received by LACDPH:

- 20 ▪ [at 15:06] MS. HAMILL: “His [Mr. Morrow’s] explanation is that there were
21 threats, which have never been identified – he couldn’t identify a single threat – um,
22 harassment and misinformation, and misinformation includes anything that is
23 contrary to whatever was coming out of Barbara Ferrer’s mouth.”
- 24 ▪ [at 16:16] MS. HAMILL: “He was unable to remember any specific threats and he
25 was unable to remember recall ever contacting law enforcement.”
- 26

27 ¹ Some of the indicated time stamps might be a bit off due to the length of different ads that
28 are inserted at the beginning of the recording.

1 On the contrary, Mr. Morrow identified at least one such threat and that it was reported to law
2 enforcement:

3 “Q. Can you think of any specific examples of threats that you described in your e-
4 mails to Twitter?

5 A. I can’t remember if I was thinking of specific threats at that time, but ***I do***
6 ***remember social media threats saying that Dr. Ferrer should be shot.***

7 Q. That was on Twitter?

8 A. I believe that was Facebook.

9 Q. Facebook?

10 A. Correct.

11 Q. ***Was that reported to law enforcement?***

12 A. I believe so.”

13 [July 7, 2023 Morrow Deposition Transcript, at 161:19-162:4 (emphasis added).]

14 14. She publicly engaged in inappropriate name-calling directed at Mr. Morrow:

- 15 ▪ [at 06:31] MS. HAMILL: “[Brett Morrow] came across as nice, somewhat aloof,
16 ***incredibly incompetent***”
- 17 ▪ [at 06:49] MS. HAMILL: “He was kind, he was polite, but it was clear to me that he
18 is, um – I feel bad saying this, because he’s so nice – but he’s ***incredibly incompetent***
19 ***and stupid.***”
- 20 ▪ [at 17:38] MS. HAMILL: “I feel so bad saying this, because he really seems like a
21 nice person, but ***I don’t think he has the intellectual capacity*** to run that office.”
- 22 ▪ [at 19:13] MS. HAMILL: “My impression of the two of them Brett Morrow and Dr.
23 Barbara Ferrer] is that they’re really ***not very bright.*** And ***they’re not, like, strategic***
24 ***geniuses*** or anything along those lines. And it could be that ***they’re just two dim***
25 ***bulbs*** who fell into a lot of power and abused it, or it could be something more
26 sinister.”
